

Guía para vincular tu nuevo pasaporte o DNI a tu 'settled status' o 'pre-settled status'

Para los ciudadanos de la UE, la prueba del 'settled status' o 'pre-settled status' es en **formato digital** a través de un perfil online. El permiso de residencia se vincula también al pasaporte o Documento de Identidad utilizado para la presentación de la solicitud.

Cuando el ciudadano actualiza el pasaporte o DNI que utilizó para presentar la solicitud, será necesario facilitar los detalles del nuevo documento al Home Office para que éste quede vinculado al permiso de residencia.

A continuación, te explicamos cómo llevar a cabo dicha actualización:

View and prove your immigration status

If you have been told you can view your immigration status online you can use this service to:

- get a 'share code' to prove your status to others, for example employers
- update your personal details, for example your passport number or email address
- check what rights you have in the UK, for example the right to work or claim benefits

Who can use this service

You can use this service if you:

- have settled or pre-settled status
- applied for a visa and used the 'UK Immigration: ID Check' app to scan your identity document on your phone

You cannot use this service if you have a vignette in your passport or a biometric residence permit to prove your immigration status. There's a different service for you to [prove your right to work](#) to an employer.

View or prove your immigration status

You'll need:

- details of the identity document you used when you applied (your passport, national identity card, or biometric residence card or permit)
- your date of birth
- access to the mobile number or email address you used when you applied - you'll be sent a code for logging in

PASO 1:

PASO 2:

Deberás seleccionar el documento que usaste para presentar la solicitud: 'PASSPORT', 'NATIONAL IDENTITY CARD' o 'BIOMETRIC RESIDENCE CARD OR PERMIT'.

PASO 3:

Introduce el **número de pasaporte o DNI** que utilizaste para presentar la solicitud.

En el caso de haber usado el DNI, el número que deberás introducir será el número que aparece en tu documento como '**NUM SUPORT**'.

PASO 4:

Introduce tu **fecha de nacimiento** en formato D/M/AAAA

PASO 5:

Selecciona si prefieres que te envíen un **código de acceso de un solo uso** al correo electrónico o al número de teléfono que facilitaste durante la solicitud.

PASO 6:

Introduce el código que hayas recibido en este apartado.

You should tell us about any changes to your personal details, such as your name and nationality. You should also tell us if your sign-in or travel document details change, so that you can continue to access your information online.

- email address
- phone number
- home address
- passport, identity card or travel document details, including change of name or nationality.

PASO 7:

Una vez hayas accedido a tu perfil online deberás seleccionar el apartado **'UPDATE YOUR DETAILS' – 'USE THIS SERVICE'**.

Una vez haya accedido deberá pulsar **'START NOW'**.

PASO 8:

Si deseas actualizar tus datos de contacto selecciona **'CONTACT DETAILS'** (teléfono, correo electrónico o dirección). Si deseas actualizar tu número de pasaporte o DNI, selecciona **'PERSONAL DETAILS'**.

PASO 9:

Selecciona qué datos personales quieres actualizar: tu nombre o tu pasaporte o DNI. Selecciona **'IDENTITY DOCUMENT'**.

PASO 10:

Selecciona **'YES'** o **'NO'** si has cambiado de nombre. En el caso en que hayas cambiado de nombre, deberás facilitar todos los detalles. Pulsa **'CONTINUE'**.

PASO 11:

Introduce tu nacionalidad.

Photo rules

Your photo must show:

- all your personal details
- the photo of you
- the machine-readable zone (at the bottom of your passport or the back of your identity card)

It must also be:

- in colour
- in focus
- unaltered by computer software (no effects or filters)

Your photo must not be:

- obscured by glare or reflections
- a photocopy of your identity document

PASO 13:
